TERMS AND CONDITIONS:

1. Their appointment is purely on contract basis extendable at the maximum up to the project life subject to satisfactory performance of the appointees and they will have no claim/right what so ever for regularization etc. Their services under the present contract shall not qualify them for pension/gratuity.
2. Their services can be terminated at one month notice. In case they wish to resign at any time, one month's notice will be necessary or in Lieu thereof one month's pay shall be forfeited.
3. Their services will be liable to termination without any notice if their performance is not found satisfactory subsequently.
4. Their services will be liable to termination without any notice if their academic documents and other credentials submitted in this office are found fake at any stage and they will be proceeded against under the law.
5. They will produce a medical certificate of fitness from the concerned Civil Surgeon/Medical Superintendent.
6. They will be governed by Provincial Government Rules concerning project contract appointments as amended from time to time.

7. Their academic documents will be verified by the District Education Officer (Female) concerned. If found fake their services will be terminated and they will be proceeded against under the law.
8. The District Education Officer (Female) concerned will release their pay after verification of their academic documents.
9. Their appointments are School based and non-transferable.
10. Their joining time of this offer is 30 days and they will have to sign a contract agreement with the concerned District Education Officer (Female) on behalf of the IT Project E&SE Department, failing which, the offer will stand cancelled. The signed contract agreement will be submitted to the IT Project, E&SE Department.
11. They will submit Charge Report to all the concerned.
12. No TA/DA will be allowed to the appointees for joining their duties.

AGREEMENT

This agreement is made on this _____ day of _____ 2016 between the concerned District Education Officer (Male/Female) of district _____ on behalf of IT Project “150559-Establishment of 500 IT Labs in Government High & Higher Secondary Schools in Khyber Pakhtunkhwa”, Elementary & Secondary Education (E&SE) Department, Government of the Khyber Pakhtunkhwa Province (hereafter referred to as the Government) acting through on the ONE PART and _____ S/D/W/O _____ appointed as Senior IT Teachers (BPS-17) on fixed pay (@ Rs. 70,000/- per month) vide E&SE Department, Government of Khyber Pakhtunkhwa Order No. _____ dated ____/____/2016 in the School _____ (hereinafter referred to as the employee) on the OTHER PART;

WHEREAS the Government has agreed to appoint the Employee and the Employee has agreed to serve the Government as on the terms and conditions hereafter mentioned:

NOW these present witnesses and the parties hereto respectively agreed as follows:-

1. The employee shall serve the Government as Senior IT Teacher (BPS-17) on fixed pay in the IT Project “150559-Establishment of 500 IT Labs in Government High & Higher Secondary Schools in Khyber Pakhtunkhwa”, under Elementary & Secondary Education Department for a period of financial year 2016-17 (extendable on satisfactory performance till project life) commencing from the date of assumption of charge of the post.
2. The Employee shall
 - a. Devote him/her to perform his/her duties as Senior IT Teacher in the IT Project “150559-Establishment of 500 IT Labs in Government High & Higher Secondary Schools in Khyber Pakhtunkhwa”.
 - b. Submit himself/herself to the lawful orders of the Government and the officers and authorities under whom his/her services may be placed from time to time, during the currency of this Agreement;
3. For the services rendered, the Employee shall be entitled to receive pay as prescribed in her/his appointment order. The pay of the employee shall commence from the date of his/her assumption of charge of the post and cease on the date of determination of this agreement or on termination of his/her services for any reason, whichever may be earlier.
4. Either party to this agreement may terminate the agreement by giving to the other party one month notice in writing of this intention to do so or on the expiration of such notice this agreement shall be terminated.

5. On completion of project, services of the employee shall be terminated.
6. His/her appointment is purely on contract basis extendable at the maximum up to the project life subject to satisfactory performance of the appointee and he/she will have no claim/right what so ever for regularization etc. His/her services under the present contract shall not qualify him/her for pension/gratuity.
7. His/her services can be terminated at one month notice. In case he/she wishes to resign at any time, one month's notice will be necessary or in Lieu thereof one month's pay shall be forfeited.
8. His/her services will be liable to termination without any notice if his/her performance is not found satisfactory subsequently.
9. His/her services will be liable to termination without any notice if his/her academic documents and other credentials submitted in this office are found fake at any stage and he/she will be proceeded against under the law.
10. He/she will be governed by Provincial Government Rules concerning project contract appointments under the project policy as amended from time to time.
11. His/her appointment is school based and non-transfer able.
