Subject: **RELEASE OF BUDGET FOR SALARY ARREARS OF IT TEACHING STAFF UNDER THE IT PROJECTS.**

Please refer to the subject cited above and to state that the Elementary & Secondary Education Department has released the requisite budget through re-appropriation for the pending salaries arrears of IT teaching staff (i.e. Senior IT Teachers B-17, IT Teachers B-16 & Computer Lab Incharges B-07) working under the following two ongoing schemes of the IT Project. (Copies of the budget release and scheme & district wise breakup of the requisite budget is enclosed)

1. 150559-Establishment of 500 IT Labs in Government High & Higher Secondary Schools in Khyber Pakhtunkhwa.
2. 160151-Establishment of 500 IT Labs in Government High Schools in Khyber Pakhtunkhwa (Phase-III).

Moreover, it is further to inform you that both the above schemes are due for completion within the current FY 2017-18. Therefore, the released salary budget is up to 30th June 2018 along with the arrears.

In view of the above, to avoid further financial hardship of the IT teaching staff under the IT Projects and avoid lapse of funds after 30th June 2018, you are therefore, requested to immediately:

2. All the pending salary arrears bills be submitted and cleared from the respective District Accounts Offices.
3. Furnish the reconciled figures of the scheme wise expenditures of funds.
