TERMS AND CONDITIONS:


1. Their appointment is purely on contract basis extendable at the maximum up to the project life subject to satisfactory performance of the appointee and they will have no claim/right what so ever for regularization etc. Their services under the present contract shall not qualify them for pension/gratuity.
2. Their services can be terminated at one month notice. In case they wish to resign at any time, one month's notice will be necessary or in Lieu thereof one month's pay shall be forfeited.
3. Their services will be liable to termination without any notice if their performance is not found satisfactory subsequently.
4. They will produce a medical certificate of fitness from the concerned Civil Surgeon/Medical Superintendent.
5. They will be governed by Provincial Government Rules concerning project contract appointments as amended from time to time.
6. Their academic documents will be verified by the District Education Officer (Male) concerned. If found fake their services will be terminated and they will be proceeded against under the law.
7. Their pay will be released subject to the condition that their academic documents are verified by the District Education Officer (Male) concerned.
8. Their appointments are School based and non-transfer able.
9. Their joining time of this offer is 30 days and they will have to sign a contract agreement with the Project Manager IT "160151-Establishment of 500 IT Labs in Government High Schools in Khyber Pakhtunkhwa (Phase-III)", E&SE Department within 30 days, failing which, the offer will stand cancelled.
10. They will submit Charge Report to the Project Manager IT and all other concerned.
11. No TA/DA will be allowed to the appointees for joining their duty.
