### **Terms and Conditions:**

1. He shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made thereunder.
2. His pay will be released subject to verification of academic documents/testimonials from the concerned Board/University by the District Education Officer (Male) concerned.
3. His services will be considered regular and he will be eligible for pension/deduction of GP Fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.
4. His services are liable to termination on one months notice from either side. In case of resignation without notice, his one month pay/allowances shall be forfeited to the Government.
5. He shall be initially on probation for a period of one year extendable for further one year as per rules.
6. He will be governed by such rules & regulations as may be issued from time to time by the Government.
7. His services can be terminated at any time, in case his performance is found unsatisfactory during probationary period. In case of misconduct, he will be proceeded against under the Khyber Pakhtunkhwa Government Sevants (Efficiency & Discipline) Rules, 2011 as amended from time to time.
8. The appointee should join his post within 30 days of the issuance of this notification. The Director E&SE Khyber Pakhtunkhwa Peshawar would furnish a certificate to the effect that the candidate has joined the post otherwise, after one month of the issuance of this Notification, failing which his candidature will expire automatically and no subsequent appeal etc shall be entertained.
9. Charge report should be submitted to all concerned.
10. No TA/DA will be allowed to the appointee for joining his duty.
