1. He shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made thereunder.

3. His services shall be considered regular and he shall be eligible for pension/deduction of GP Fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.
4. His services are liable to termination on one month notice from either side. In case of resignation without notice, his one month's pay/allowances shall be forfeited to the Government.
5. He shall be on probation for initial period of one year extendable for further one year as per rules.
