Subject: - <u>ELECTION FOR FOUR MEMBERS FROM PRIVATE SCHOOLS FOR</u> <u>"KHYBER PAKHTUNKHWA PRIVATE SCHOOLS REGULATORY</u> AUTHORITY"

Memo:

I am to refer to the subject noted above and to state that Khyber Pakhtunkhwa Private Schools Regulatory Authority Bill, 2017 has been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 23rd May, 2017 and assented by the Governor on 8th June, 2017 and has been published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa as <u>KHYBER</u> <u>PAKHTUNKHWA PRIVATE SCHOOLS REGULATORY AUTHORITY ACT, 2017</u> (KHYBER PAKHTUNKHWA ACT NO.XXV OF 2017) on 09.06.2017 to establish an Authority for registration, regulation and supervision of Private Schools in the Province of Khyber Pakhtunkhwa.

In pursuance of Section-3 of the Khyber Pakhtunkhwa Private Schools Regulatory Authority Act, 2017 Government of Khyber Pakhtunkhwa has established the Khyber Pakhtunkhwa Private Schools Regulatory Authority vide Notification No.SO (B&T) E&SE/2-7/2017/Regulatory Authority dated Peshawar the 10-08-2017.

Under CHAPTER-II Section 4 sub-section (1) clause (f) four members of the Regulatory Authority will from Private schools and under the provision of Section 4(2) the members at subsection (1) clause (f) shall be elected for the fix term of three years in the manner and on the conditions as may be prescribed.

First meeting of the Regulatory Authority was held today on 28.08.2017 at 11.00 AM in the Committee Room of E&SE department under the chairmanship of the Secretary Elementary and Secondary Education Government of Khyber Pakhtunkhwa, Chairperson of the Regulatory Authority. Regulatory Authority delegated the powers to the Director E&SE member of the Regulatory Authority, to hold the election for the four members of the Regulatory Authority from Private schools.

It was also decided that four members will be elected one each from the following area.

- 1. One member from the Private schools of Central region of Khyber Pakhtunkhwa (under the jurisdiction of BISE Peshawar, BISE Mardan).
- 2. One member from the Private schools of southern region of Khyber Pakhtunkhwa (under the jurisdiction of BISE Kohat, BISE Bannu and BISE DI Khan),
- 3. One member from the Private schools of Hazara region of Khyber Pakhtunkhwa (under the jurisdiction of BISE Abbottabad).
- 4. One member from the Private schools of Malakand Division region of Khyber Pakhtunkhwa (under the jurisdiction of BISE Peshawar, BISE Malakand and BISE Swat).

The following Chairman BISEs are hereby declared as Returning Officers for the regions noted against each.

Chairman BISE Mardan will send the District wise lists of registered private schools (under the jurisdiction of, BISE Mardan) to the Chairman BISE Peshawar Returning Officer for member-I to be elected from Private schools of Central region of Khyber Pakhtunkhwa and Chairman BISE Bannu and BISE DI Khan will send the District wise lists of registered private schools (under the jurisdiction of BISE Bannu and BISE DI Khan respectively) to the Chairman BISE Kohat, Returning Officer for member-III to be elected from Private schools of southern region of Khyber Pakhtunkhwa , Chairman BISE Peshawar and BISE Swat will send the District wise lists of registered private schools (under the jurisdiction of BISE Peshawar respectively) to the Chairman Gofficer for member-IV to be elected from Private schools of Malakand Returning Officer for member-IV to be elected from Private schools of Malakand Division of Khyber Pakhtunkhwa (under the jurisdiction of BISE Peshawar, BISE Malakand and BISE Swat).

- *Note:* 1. Election Schedule will be announced shortly.
 - 2. Only registered Private school working in Khyber Pakhtunkhwa can Vote or contest Election for the member of the Regulatory Authority from Private schools of that area/region.
 - 3. No registered Private school of FATA or other than working in Khyber Pakhtunkhwa (under the jurisdiction of any BISE) can Vote or contest Election for the member of the Regulatory Authority from Private schools.
 - 4. "Private School" means a school in the Private Sector including Montessori, Kindergarten, tuition academy or centre, primary, middle, high, higher Secondary Schools or in institution f equivalent level imparting education through any system of education or medium of instruction in private sector.
 - 5. Certain persons to be ineligible for nomination or election or continuation as member. -

A person shall not be appointed or continue as member if he:

- (a) is convicted of an offence involving moral turpitude or misappropriation of property or breach of trust under the Pakistan Penal Code 1860 (XLV of 1860); or
- (b) is found guilty of inefficiency, misconduct or corruption; or
- (c) is declared to be of unsound mind by a court; or
- (d) is adjudged as an undischarged insolvent; or
- (e) is incapable of discharging duties by reason of physical or mental infirmity and has been so declared by a Medical Board; or
- (f) fails to disclose to the Regulatory Authority any conflict of interest with the Regulatory Authority within six working days of his knowledge of the conflict of interest; or
- (g) stands disqualified by the order of a court to hold any public office; or
- (h) is dismissed from the service of Pakistan or a body or authority owned or controlled by any government in Pakistan.
