Terms and Conditions:

- 1. They shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made thereunder.
- 2. Their pay shall be released subject to verification of academic documents/testimonials from the concerned Board/University by the District Education Officer (Male) concerned.
- 3. Their services shall be considered regular and they shall be eligible for pension/deduction of GP Fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.
- 4. Their services are liable to termination on one month notice from either side. In case of resignation without notice, their one month's pay/allowances shall be forfeited to the Government.

- 5. They shall be on probation for initial period of one year extendable for further one year as per rules.
- 6. They shall be governed by such rules & regulations as may be issued from time to time by the Government.
- 7. Their services can be terminated at any time, in case their performance was found unsatisfactory during probationary period. In case of misconduct, they will be proceeded against under the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 as amended from time to time.
- 8. The appointees shall join their posts within 30 days of the issuance of this notification and the Director E&SE Khyber Pakhtunkhwa Peshawar shall furnish a certificate to the effect that the candidates have joined their posts, failing which their candidature shall expire automatically and no subsequent appeal etc shall be entertained.
- 9. Charge assumption report should be submitted to all concerned.
- 10. No TA/DA shall be allowed to the appointees for joining their duties.
