The formal proceedings of the meeting started with the recitation from the Holy Qura'an. After that, the Chairman welcomed all the participants with preliminary short speech. Below are the salient points of the meeting duly recorded.

- All the participants introduced themselves.
- 2. Only one member (Assistant Director (EMIS) E&SED) was not present.
- 3. Next, the Assistant Director (SQMI-M) opened the bid envelops and announced the quoted prices/bids by the various firms in detail.
- 4. Some firms did not clearly quote brand of the items & to that effect their bids were rejected.
- 5. Upon scrutiny of the bid documents, the following four (04) firms were found ineligible as they did not fulfil the basic eligibility/qualification criteria.
  - a. Falcon Business Enterprises was rejected due to non-availability of company/firm registration certificate. (As per criteria S.No.1 of basic eligibility/qualification criteria of the firms)
  - b. AurSoft firm was rejected due to its presence on non-active tax-payer list as of 22-Apr-2021 @ 1245 hrs on FBR Active Taxpayer List (ATL). (As per criteria S.No.2 of basic eligibility/qualification criteria of the firms)
  - c. City Enterprises was rejected due to non-availability of company/firm registration certificate. In addition, the firm also did not provide undertaking of online verifiable part numbers and supply schedule on company letter head. (As per criteria S.No.1 & 5 of basic eligibility/qualification criteria of the firms)
  - d. M/S Lalzada Khan & Company was rejected due to non-provision of certificate/documents showing the track record of completing at least two (02) similar assignments involving the supply of comparable scale. (As per criteria S.No.4 of basic eligibility/qualification criteria of the firms)
