

Terms and Conditions:

1. They shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made thereunder.
2. Their pay shall be released subject to verification of his academic documents/testimonials from the concerned Board/University by the District Education Officer (Male) concerned.
3. Their services shall be considered regular and they shall be eligible for pension/deduction of CP Fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2022.
4. Their services are liable to termination on one-month notice from either side. In case of resignation without notice, their one-month's pay/allowances shall be forfeited to the Government.
5. They shall be on probation for initial period of one year extendable for further one year as per rules.
6. They shall be governed by such rules & regulations as may be issued from time to time by the Government.
7. Their services can be terminated at any time, in case his performance was found unsatisfactory during probationary period.
8. No TA/DA shall be allowed to the appointee for joining duty.
