It is stated that under Section-4 of the Khyber Pakhtunkhwa Education Employees Foundation Act-2018 and Regulation-10 of the Khyber Pakhtunkhwa Education Employees Foundation Welfare and Financial Assistance Regulations-2021 an Education Employee OR one of his/her children is entitled for marriage grant out of EEF Funds. The marriage grant is given only once to those Education Employees OR one of his/her children who have at least twenty years of service. However, most of the Education Employees are unaware about the said grant.

Therefore, I am directed to enclose herewith a copy of Marriage Grant application form (Revised) for circulation amongst the offices / institutions working under your jurisdiction / control for the awareness of Education Employees with the instructions to submit their marriage grant application forms (Revised) to this office through proper channel duly attested by the concerned authorities mentioned in the application form alongwith photocopies of required documents.

- 10. In Case of Death, the application in addition to the above mentioned documents must be accompanied by the following documents: -
  - Death Notification of the Education Employee;
  - ii) List of Family Members;
  - iii) Death Certificate of the deceased Education Employee;
  - iv) Affidavit on stamp paper to the effect that widow or widower, as the case may be, has not contracted a second marriage;
  - v) National Identity Card of the concerned family member; and
  - vi) No Objection Certificate from other family members on judicial stamp paper to the effect that they have no objection to the application for financial assistance.

**NOTE:** - Application for Marriage Grant shall be made within a period of **TWO YEARS** from the date of Nikah and the marriage grant shall be given only once to those Education Employees or his children, as the case may be, who have at least **TWENTYYEARS** of service.
