MINUTES OF THE PROCUREMENT MEETING HELD ON 29-10-2024 REGARDING PROCUREMENT OF BLADE SERVERS

Pursuant to Procurement Committee meeting decision regarding opening of Technical Evaluation, a sub-committee was constituted for technical evaluation under the chairmanship of Procurement Specialists ASPIRE with representation of Director EMIS and Deputy Director Data Base ST&IT Department. Upon receipt of subcommittee report, the procurement committee meeting for discussion was held under the Chairmanship of Additional Secretary (General), E&SE on 20th September, 2024 at 03:00 hours in his Office at Elementary & Secondary Education Department. The committee approved the recommendations of sub-committee, therefore, result displayed on the official website of Elementary & Secondary Education Department as well as KPPRA and also given time of fifteen days (15) to submit grievance against the evaluation if any. No firm came with the grievance, however, during verification process, few work orders of responsive firm namely M/S Oppels Tech couldn't verify. In the meanwhile, the Procuring entity approached the responsive firms to give willing in extension of bid time for another period of sixty days under Section 35 of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority Rules 2014 (amended time to time).

- 2. In response, two firms namely M/S Computer Point and M/S Computer Marketing Company conveyed their consent on bid extension (Annex-I & II) while the M/S Oppels Tech regretted their consent for further proceeding on the bid. Therefore, financial bid opening meeting of subject procurement was held on 29-10-2024 at 0200 hours in the Committee room of E&SE Department under the Chairmanship of Additional Secretary (General), E&SE. The following committee members were present;

 - ii. Procurement Specialist, ASPIRE;
 - iii. Monitoring & Evaluation Specialist ASPIRE;

- b. M/S Computer Marketing Company quoted rate is Rs. 33,488,084/-
- 5. Therefore, the Computer Point has been found the lowest bidder. Detail comparative statement is added. The committee recommended the lowest bidder for work order after observing all codal formalities.
