- 3 Their services can be terminated at any time, in case their performances are found unsatisfactory during probationary period. In case of misconduct, they shall be proceeded under the rules framed from time to time.
- 4 Charge report should be submitted to all concerned.
- 5 No TA/DA is allowed for joining the duty.
- 6 They will give an under-taking to be recorded in their Service Book to the effect that if any over payment made to them in the light of this order, will be recovered, and if they are wrongly promoted, they will be reverted/reversed.

7 Before handing over the charge, once again their documents may be checked and if they have not the prescribed qualifications as per rules, they may not be handed over charge of the post.

The prescribed qualifications/ documents may be verified from the concerned Universities/ Institutions by the DEO concerned, before releasing the pay.
