## **NOTIFICATION**

NO.SO(SMC)E&SED/4-5/SSRC/SMC/Amendment/2025: In pursuance of the provision contained in sub-rule (2) of rule 3 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, the Elementary and Secondary Education Department, in consultation with the Establishment Department and the Finance Department, hereby directs that in this Department's Notification No. SO(SM)E&SED/3-2/2016/SSRC of MC, dated 27.03.2019, the following further amendments shall be made, namely:

## **AMENDMENTS**

- 1. In the Preamble, for the words "Schools Management Cadre", the words "Education Management Cadre" shall be substituted.
- 2. In the APPENDIX,-
  - (a) against Serial No. 1, in Column No. 5, the full stop appearing at the end of the Note, shall be replaced by a colon and thereafter the following shall be added, namely:
    - "Provided that the condition of mandatory training for promotion mentioned above shall be applicable w.e.f. 01.01.2026."
  - (b) against Serial No. 2, in Column No. 5, the full stop appearing at the end of clause (iii), shall be replaced by colon and thereafter the following shall be added, namely:

"Provided that the condition of mandatory training for promotion mentioned above shall be applicable w.e.f. 01.01.2026.

**Note:** For the purpose of promotion, separate seniority lists of Male and Female Deputy District Education Officers (BPS-18) and Deputy Directors (BPS-18), shall be maintained.";

- (c) against Serial No. 3, in Column No. 5,-
  - (i) in clause (a), the semicolon and the word "and", appearing at the end of sub-clause (iii), shall be replaced by a colon and thereafter the following shall be added, namely:

"Provided further that the condition of mandatory training for promotion mentioned above shall be applicable w.e.f. 01.01.2026; and"; and

(ii) after clause (b), the following shall be added, namely:

"Note: For the purpose of promotion, separate seniority lists of Male and Female Sub-Divisional District Education Officers (BPS-17) and Assistant Directors (BPS-17), shall be maintained.";



(d) against Serial No. 4, in Column No. 5, in clause (a), the semicolon and the word "and", appearing at the end shall be replaced by a colon and thereafter the following shall be added, namely:

"Provided that the condition of mandatory training for promotion mentioned above shall be applicable w.e.f. 01.01.2026.

Note: For the purpose of promotion, separate seniority lists of Male and Female Assistant Sub-Divisional District Education Officers (BPS-16) and Assistant District Education Officers (BPS-16), shall be maintained; and".
