Terms and Conditions:-

1. They will be on probation for the period as specified in Rules (15) substituted vide - No.SO (Policies)/E&AD/1-3/2017 Dated, 07-12-2017 in Appointment, Promotion and Transfer Rules, 1989 (**for Promotees Only**).
2. They will be governed by such rules and regulations as may be issued from time to time by the government.
3. Their Inter-Se- Seniority on lower post will remain intact as per Rules (17)(4) of Appointment, Promotion and Transfer Rules, 1989.
4. They will give an under taking to be recorded in their service books to the effect that if any over payment is made to them in the light of this order, will be recovered and if wrongly promoted, will be reversed.
5. Before handing over charge, their documents may be checked. If they have not the required relevant qualification as per rules, they may not be handed over the charge of the post.
6.
