- 2. They will be governed by such rules and regulations as may be issued from time to time by the government.
- 3. Their Inter-Se- Seniority on lower post will remain intact as per Rules (17)(4) of Appointmet, Promotion and Transfer Rules, 1989.
- 4. They will give an under taking to be recorded in their service books to the effect that if any over payment is made to them in the light of this order, will be recovered and if wrongly promoted, will be reversed.
- 5. Before handing over charge, their documents may be checked. If they have not the required relevant qualification as per rules, they may not be handed over the charge of the post.
- 6. The Candidate lacking Bachelor Degree in Education (B.Ed) or equivalent qualification from a recognized University, shall acquire the same within three years from the date of their promotion orders, otherwise their Promotion Orders shall be stood cancelled after the stated stipulated period (only for SST IT).
- 7. Their credential may be verified from the concerned authorities/offices if not verified previously.
- 8. Charge report should be submitted to all concerned.
- 9. No TA/DA is allowed for joining the duty.
