#### Terms & Conditions:

- 1. They shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made thereunder and any other instruction(s) issued by the Govt; from time to time.
- 2. Their pay shall be released subject to verification of academic documents/testimonials from concerned Board/University by the District Education Officer (Male) concerned.
- 3. In light of section-19 (2) of the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Amended in 2022), they shall not be entitled for pension and gratuity. They shall in lieu of pension and gratuity be entitled to receive such amount contributed by them towards Contributory Provident Fund along with the contributions made by the Government to their account in the said Fund, in the prescribed manner as provided in the Khyber Pakhtunkhwa Civil Servants Pension Rules, 2021.
- 4. They shall remain on probation for a period of one year, in terms of Section 6(1) of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with 15(1) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 which is extendable for another year with specific order of appointing authority within two month of expiry of first year of probation period as specified in Rule-15(2) of the rules ibid.
- 5. Their services shall be liable to be terminated at any time without assigning any reason before the expiry period of initial probation/extended period of probation if their performance during this period is found un-satisfactory. In such an event, they shall be given one month prior notice of termination from service or one month pay in lieu thereof. In case they wishes to resign at any time, one-month prior notice shall be necessary or in lieu thereof, pay for month shall be forfeited.
- 6. The appointees shall report to Directorate of E&SE within 30 days of the issuance of this notification. The Director E&SE Khyber Pakhtunkhwa would furnish a certificate to the effect that the candidates have submitted arrivals, failing which their candidature shall be expired automatically and no subsequent appeal etc. shall be considered.
- 7. They shall produce a stamp paper of denomination that if their documents/credentials are found bogus during verification or at a later stage, they shall refund the entire remuneration

in government treasury through challan, besides any other legal action under the relevant laws.

8. They shall not be entitled to any TA/DA for joining their duties.
