NO.SO(SM)E&SED/DPD/DCTE/RPDCs/Reforms/2025: In supersession of all previous Notifications/ Orders/ Instructions in this behalf, the competent authority i.e. Secretary E&SE Department has been pleased to issue the following instructions to ensure transparency and better public delivery by Directorate of Professional Development (DPD), Directorate of Curriculum & Teachers Education (DCTE),

Abbottabad and Regional Professional Development Centers (RPDCs) in Khyber Pakhtunkhwa with immediate effect in the best public interest:-

- i. All the posts/ vacancies in DPD, DCTE & RPDCs shall be advertised through the official website of E&SE Department, DPD, DCTE & RPDCs as the case may be.
 - ii. The recommendations for Placement through Provincial Placement Committee (PPC) shall be made strictly in accordance with the service rules enforced for the time being, in public interest.
 - iii. The recommendations of PPC shall only be made to a post if the incumbent fulfils the qualification, experience and as per approved criteria annexed.
 - iv. The authority to recommend for placement of officers at DPD/ RPDCs shall rest with the PPC, which shall consists of the following members:-

1. Secretary E&SE Department.

2. Director, E&SE Khyber Pakhtunkhwa.

Director, DPD Khyber Pakhtunkhwa in case of DPD. Director DCTE Abbottabad in case of DCTE.



- Prepare working paper with complete record alongwith final recommendations to be placed before PPC within a month of holding interviews.



- (3) i. The tenure of posting at DPD, DCTE & RPDCs shall be minimum for three years, which may be extendable for a further term of two years depending upon their performance.
 - ii. The PPC may have the powers to remove any incumbent prior to completion of his/ her tenure. However, an internal appeal before the Secretary E&SED can be made whose decision would be final.
 - iii. For approval of posting of (BS-17) officers, the Secretary E&SED, for (BS-18) officers, the Minister E&SED and for (BS-19) & above officers, Chief Minister Khyber Pakhtunkhwa shall be the competent authority.
