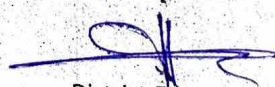

Tender Notice

I am directed to refer to the subject noted above and to inform you that the following discrepancies have been noticed in your Tender Notice advertised in "Daily Mashriq" dated 06th December, 2025 copy attached for ready reference.

Rule 11 (1 & 2) of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services, Rules 2014 (Rules), reproduced below necessitates that all the procuring entities shall publish/upload their advertisements on KP-PPRA website

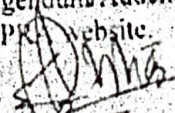
"The procuring entity shall engage in open competitive bidding, if the cost of the object to be procured is more than the financial limit, which is applicable under rule 10. Purchases up to Rs. [5] million shall be posted on the procuring entity's website and Authority's website, respectively. These procurement opportunities may also be advertised in print media, if deemed necessary by the procuring entity. For all purchases, other than those being covered in rules 5, 10 and sub-rule (1) of rule 11 of these rules, shall be advertised in print media, appearing in at least one national English and one Urdu daily newspaper with nationwide circulation along with advertising the same on the procuring entity's website and Authority's website, respectively."

Further, the procuring entity has not mentioned the bid opening date, which is violation of Rule 37(6) which states as:

"All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same"

It is pertinent to mention that as per section 2(1) (n) of KP-PPRA Act, 2012, read in conjunction with Rule 54, Public Procurement in contravention to the provisions of this Act or any other law in respect of or relating to public procurement, including any rules, regulations, orders or instructions made in this behalf shall constitute mis-procurement and person responsible for such breach shall liable to be proceeded under the relevant law.

In view of above, it is advised, to rectify the same (by issuing Addendum/Corrigendum) and also send copies of the advertisement/Corrigendum/Addendum either in hard or through email ID info@kppra.gov.pk for uploading on KP-PPRA website.
