CIRCULAR.

No. SOG/E&SE/1-31/2026. Pursuant to the decision of the Provincial Cabinet in its meeting held on 09-03-2026 regarding regional situation affecting petroleum supplies and price, and possible impact on national foreign exchange reserves, the Govt: of Khyber Pakhtunkhwa has approved a set of temporary fuel conservation and responsible governance measures for a period of two months aimed at reducing non-essential fuel consumption.
