**Invitation of E-Bids for Provision of Consultant Services for developing
Students Wellbeing & Nutrition Policy/Plan for E&SED Khyber Pakhtunkhwa
(E-PADS System - Single Stage Two Envelope)**

E-Bids are invited through EPADS from Firms/Companies/Consultants for the provision of consultant services to develop a Students Wellbeing & Nutrition Policy/Plan for the Elementary & Secondary Education Department, Khyber Pakhtunkhwa. The firm/Bidder must be registered with KPRA, FBR for Income Tax, and reflected on the Active Tax Payer (ATL) list of FBR. Details of the tender, specification, and submission are provided in the standard bidding document.

TERMS AND CONDITIONS:

1. The Elementary & Secondary Education Department, Government of Khyber Pakhtunkhwa, invites electronic proposals from reputable firms/consultants registered with KPRA/FBR for the Action to Strengthen Performance for Inclusive and Responsive Education (ASPIRE)
2. Interested bidders must submit their technical and financial bids through the E-Pak Acquisition and Disposal System (EPADS) by accessing <https://kp.eprocure.gov.pk/>.
3. The selection process will be conducted under the "**Quality and Cost Based Selection (QCBS)**" method, following the KPPRA Rules 2014 and the instructions provided in the RFP documents.
4. **Mandatory Documents:** Scanned copies of the following, along with the technical proposal, must be uploaded to EPADS:
 - An affidavit stating the firm is not blacklisted by any government organization.
 - Detailed profiles of key team members and evidence of completed similar projects.
 - CDR (2% Original must be submitted to the office before the deadline, with a scanned copy uploaded on E-PADS).
5. Bids must be submitted electronically by uploading scanned copies of all required documents onto the EPADS platform by **April 27, 2026, by 02:00 PM (PST)**.
6. The **original CDR** must be physically delivered to the office of the Project Director ASPIRE E&SED, Peshawar, on or before **April 27, 2026, by 02:00 PM (PST)**. Without the accompanying scanned CDR, the bid offer will be rejected outright.
7. Bids will be opened on **April 27, 2026, at 02:30 PM (PST)** in the presence of the bidders or their representatives who may choose to attend.
8. All applicable government taxes will be deducted at source as per prevailing laws and rules.
9. Bids submitted through courier, postal services, hand delivery, email, or fax will **not** be accepted under any circumstances.
10. The complete bidding process, from document download to bid submission, will be conducted exclusively through the EPADS online portal.
11. The undersigned reserves the right to reject any or all bids or proposals at any stage before the acceptance of a bid, as stipulated in Rule 47 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works, and Services Rules, 2014.
12. **Note:** E-bids submitted through mail, courier, or by hand will be rejected. Only registered bidders on E-PADS are eligible to participate.
