Zubaida Hanif VS Government of Khyber Pakhtunkhwa and Others & Execution Petition No 677/2022, on the recommendations of the Provincial Selection Board-I in its meeting held on 16.02.2026, consequent upon approval of the competent authority (Chief Minister, Khyber Pakhtunkhwa), **Mst. 
2. The officer is hereby allowed to actualize her promotion against already occupied post of DEO (F) Torghar.
