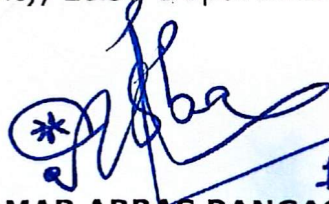
03. Consequent upon above, the afore-mentioned officers are allowed to actualize their promotion in BS-18 against the already occupied posts.
